## **My Choice Wisconsin Long Term Care Provider Network Reopens May 1, 2025**

As you may know, the My Choice Wisconsin by Molina Healthcare (MCW) Family Care and Family Care Partnership long term care provider networks have been closed to new applications. We are pleased to announce that, effective **May 1, 2025**, our network is reopening to new long-term care provider applicants.

In addition, providers interested in joining our network for Dual Advantage (D-SNP) may also apply.

To be eligible to apply, all new FC and FCP providers must:

- Be **Home and Community-Based Services (HCBS) compliant**, where applicable.
- Be **enrolled with Wisconsin Medicaid through ForwardHealth Portal**, where applicable.
- Be eligible and appropriately licensed to provide services under applicable benefit programs, including Family Care, Family Care Partnership, or Dual Advantage (D-SNP), if applicable.

*(Note: As of May 1, 2025, My Choice Wisconsin / Molina Healthcare requires Medicaid enrollment to be complete at the time of application for those provider types DHS designates as eligible to enroll. See detailed DHS enrollment guidance below.)*

### **Please Note:**

Although the Wisconsin Department of Health Services (DHS) requires all long-term care providers to be enrolled with Medicaid by **January 1, 2026**, My Choice Wisconsin / Molina Healthcare requires **Medicaid enrollment to be complete at the time of application** as of **May 1, 2025**.

Supportive home care organizations and providers with a unique Electronic Visit Verification (EVV) provider agency ID, who are not yet able to enroll with Wisconsin Medicaid through ForwardHealth, may still submit an application to join the MCW provider network. This is subject to change as ForwardHealth capabilities update to accommodate providers with EVV.

## LTSS Medicaid ID reminder

As a My Choice Wisconsin by Molina Healthcare provider or vendor, you are an important part of getting quality, timely care to Wisconsin adults who are older or have disabilities. We want to remind you about a new requirement for you to enroll with Wisconsin Medicaid through the ForwardHealth Portal by January 1, 2026.

### Who should enroll now

If you are any of the following provider types, you should enroll as soon as possible:

- Organizations and agencies
- Sole proprietors
- Individuals who are not self-directed support workers
- Individuals who deliver supportive home care along with other services

While the deadline is January 1, 2026, starting now will allow you to be listed in the public-facing ForwardHealth Provider Directory. You can easily choose the services you want to deliver, and the programs relevant to you.

### Who will enroll later this year

If you are any of the following provider types, you should wait to enroll:

- Supportive home care organizations
- Providers with a unique Electronic Visit Verification (EVV) provider agency ID

ForwardHealth will let you know when you can enroll, likely in mid-2025. You'll have until January 1, 2026, to enroll.

### Who does not need to enroll

If you are any of the following provider types, this new requirement does not affect you and you do not need to enroll:

- Participant-hired workers

- Individual self-directed support workers

How to get started enrolling now

First, gather materials

You'll need the following information to complete your application:

- Tax identification number(s)
- National Provider Identifier (NPI), if you have one
- Address
- Name and address of owners and managing employees
- Any applicable professional license or certification information

Next, start your application
